

11. The institute/university will furnish to the DST, Utilization Certificate and audited Statement of Accounts pertaining to the grant immediately after the end of each financial year.

12. The institute/University will maintain separate audited accounts for the project. If it is found expedient to keep apart or whole of the grant in a bank account earning interest, the interest earned should be reported to the DST. The interest thus earned will be treated as a credit to the institute to be adjusted towards further installment of the grant.
